JOB DESCRIPTION:

The Quality Assurance Specialist supports the implementation of the Company's Quality Systems in compliance with applicable regulations, state requirements, and other Company policies. Described below are the general responsibilities of this position.

KEY RESPONSIBILITIES / DUTIES:

- Support the implementation and improvement of the Quality Systems to ensure laboratory compliance to applicable regulations and requirements such as ISO/IEC 17025, TNI, DoD Quality System Manual, state requirements and company policies.
- Facilitate Document Control activities including processing and tracking controlled documents, developing and maintaining spreadsheets, and facilitating the annual periodic document review process.
- Support ongoing compliance to DOD and TNI requirements for laboratory QC. Issue process sheets, track, enter, review and compile QC data for quarterly and annual assessment.
- Prepare quality control charts for management review.
- Assist Quality management in maintaining state certifications/accreditations by supporting the preparation and review of renewal applications.
- Participate in Quality Systems training, collaborate with internal functional groups to address quality issues, and assist in quality related investigations as needed.

- Maintain, update and improve QA databases/spreadsheets, scan and archive documents, and organize and improve QA filing systems.
- Enter and verify proficiency testing data into vendor's online portal.
- Support the review and revision of SOPs, QAPP worksheets, and controlled forms.
- Issue, track and process IPR/DOCs.
- Support the implementation of the CAPA program.
- Support oversight of equipment maintenance and calibrations such as thermometers, hoods and balances.
- Provide QA support during internal and external audits.
- Develop to become a subject matter expert in Quality Systems.
- Other duties as assigned by management.

- Bachelor's degree in either chemistry, microbiology, toxicology, biology, or the equivalent combination of education and experience.
